

The lecture started with the introduction of the speaker by Mr. Dhruv Malik, Asst. Prof. (Law) followed by a welcome note and bouquet presentation by Prof. B.R. Saini. Worthy Speaker started with introduction of collegiums system and the speaker drove through the entire history of the emergence of collegiums system briefing about main event and the cases. She briefly pointed out the flaws in the system and how it is being misused and what all challenges the system faces which needs to be amended.

The Collegium system is system of appointing and transferring the judges, which include Chief Justice of India and four senior-most judges of the Supreme Court. However, it has no place in the Indian Constitution. The system was evolved through Supreme Court judgments. The Central government has criticised it saying it has created an imperium in imperio (empire within an empire) within the Supreme Court.

The Supreme Court Bar Association has blamed it for creating a "give-and-take" culture, creating a rift between the haves and have-nots. "While politicians and actors get instant relief from courts, the common man struggles for years for justice."

In the end she highlighted the merits and demerits of both the systems and how a new method of procedure needs to be enacted in order to cater to the need of filling the large number of vacancies of judges in court harming our justice delivery system.

The event ended with interaction and question answer round with the students and the vote of thanks by Prof Sanjay Singh.

WORKSHOP ON "LEGAL PERSPECTIVE OF MODERN SCENERIO IN SEBL" BY DR.VIJAY KUMAR SINGH

REPORT

The FIMT-School of law organized a workshop on "Legal Perspective of Modern Scenerio in SEBI" on 23rd February, 2017 by Dr. Vijay Kumar Singh, presently heading the School of Corporate Law as Associate Professor in *Indian Institute of Corporate Affairs (IICA)*, a think-tank and capacity building institute under the Ministry of Corporate Affairs, Government of India for the students of B.A. LL.B. and BBA LL.B. (4th Semester) in the Multi-Purpose hall of wing "A". The workshop commenced with the welcome speech followed by a heartwarming benison recital by the students. The dais was marked by the presence of esteemed Prof. (Dr.) B.R. Saini and Prof. (Dr.) Sanjay Singh, Directors, FIMT-School of Law welcomed and accompanied Dr. Vijay Kumar Singh.

In his workshop, Dr. Vijay Kumar Singh emphasized on how the Government of India has been taking major initiatives to activate the Commodity Exchanges for enhancing the role of commodity futures as a major risk containment tool in the commodity sector. Entry of securities brokers in commodities futures market, though considered generally as a welcome initiative for commodity market development, could not be taken forward as the existing legal framework does not permit the engagement of securities brokers in any business other than that of securities. He emphasized on the background of SEBI, constitution of the committee, participation of Securities Brokers in Commodity Futures Market, Utilization of existing infrastructure of stock exchanges, Risk containment measures and various other related information. Dr. Vijay Kumar Singh futher pointed out the distinctive operational characteristics of commodity market, contrasted to the securities market, the imperative need of training and guidance to market intermediaries like securities brokers, and thus enable them to acquire the requisite specialized knowledge and skills to operate in the chosen niche of the commodity markets. His accumulated experience and knowledge gave a wonderful approach of learning the law to the students. The students participated with utmost enthusiasm which provided them with the purpose of understanding legal theory for discovering legal fallacies of SEBI which would otherwise remain unnoticed UM.

About the Topic: The session commenced with a basic discussion on Android Application Development. "Android apps can be written using Kotlin, Java, and C++ languages" using the Android software development kit (SDK), while using other languages is also possible. All non-JVM languages, such as Go, JavaScript, C, C++ or assembly, need the help of JVM language code, that may be supplied by tools, likely with restricted API support. Some programming languages and tools allow cross-platform app support (i.e. for both Android and iOS). Third party tools, development environments, and language support have also continued to evolve and expand since the initial SDK was released in 2008.

Mr. Piyush Pandey has also discussed about the tools of application development and their implementation.
