

#### **ELIGIBILITY AND TEAM COMPOSITION:-**

- a) The competition is open to all students enrolled bona fide on a regular basis in a 5 Year or 3 Year law course or its equivalent, conducted by any recognized College/ Institution/ University.
- b) Each team shall comprise three members, two of whom shall be designated as speakers, and the third member shall be designated as a researcher.

#### **LOCATION:-**

The Competition will be conducted virtually on **14**<sup>th</sup> & **15**<sup>th</sup> **March**, **2024**. The final round will be conducted on **March 30**<sup>th</sup> , **2024**, in physical mode at FIMT Campus, Kapashera, New Delhi 110037.
