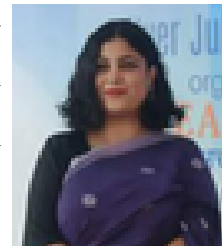

2ND NATIONAL MOOT COURT COMPETITION

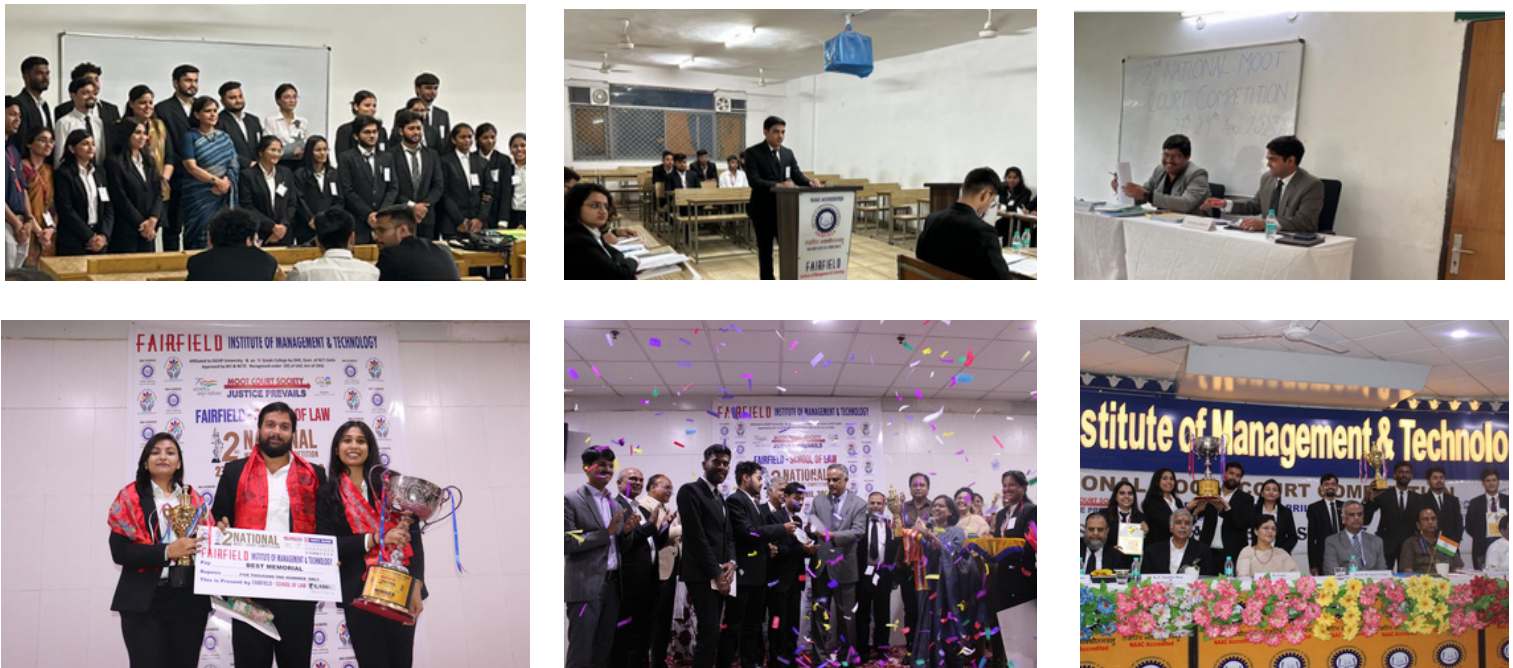

FACULTY ACHIEVEMENTS



PROF. (DR.) SHAVETA GAGNEJA has published an insightful article titled "Mediation of Commercial Dispute: A Burgeoning Approach to Conflict Resolution" in the FIMT Law Journal, shedding light on alternative dispute resolution methods. Additionally, her chapter "Perspective in Education and Legal Education" in Conference Proceedings of National Conference on Curriculum Development and Pedagogy for Legal Education in Contemporary India showcases her scholarly insights. She has also authored the book "Victimology and Victim Justice" published by Thomson Reuters, further establishing her authority in legal literature. She was invited as an expert in several high-profile events, including training programmes for law officers on loan recovery mechanisms, webinars on legal aspects like misuse of legal sections, and as a resource person for courses in gender studies and SCs/STs rights.

DR. MANISH KUMAR YADAV has attained significant accomplishments in academia, notably leading a funded research project on India's constitutional foundations' evolution. Additionally, sir co-authored a chapter on reimagining vocational education in the book "Journey of Education Policies in India," published by Bookman Publishers, Delhi. Moreover, sir presented a research paper on International Humanitarian Law at the International Conference on "War Politics and Peace in the Globalized World," organized by the Institute of Objective Studies in New Delhi. Further showcasing expertise, sir co-presented a paper with Prof. (Dr.) S. P. Singh on the "Relevance of Political Science in Legal Education" at the National Conference on Curriculum Development and Pedagogy for Legal Education in Contemporary India.

SWATI PANDITA has achieved significant milestones in her academic and research endeavors. Firstly, she contributed a book chapter titled "Right to be Forgotten: A Study with Special Reference to India" in the book "Data Privacy and Law," showcasing her expertise in legal matters concerning data protection. Additionally, she presented and published papers in national conferences, addressing critical issues such as "Issues in Higher Educational Institutions: A Critical Study of Private Colleges in Delhi NCR" and "Online Learning: An Exploratory Study of Barriers with Reference to Students in Higher Educational Institutions." Her contributions to the FIMT Law Journal with the paper "AI and the Indian Legal System - A Way Forward" further demonstrate her dedication to advancing legal discourse and research.

In addition to this, she has also presented paper on working of International Criminal Court at the International Conference on "War Politics and Peace in the Globalized World," organized by the Institute of Objective Studies in New Delhi.

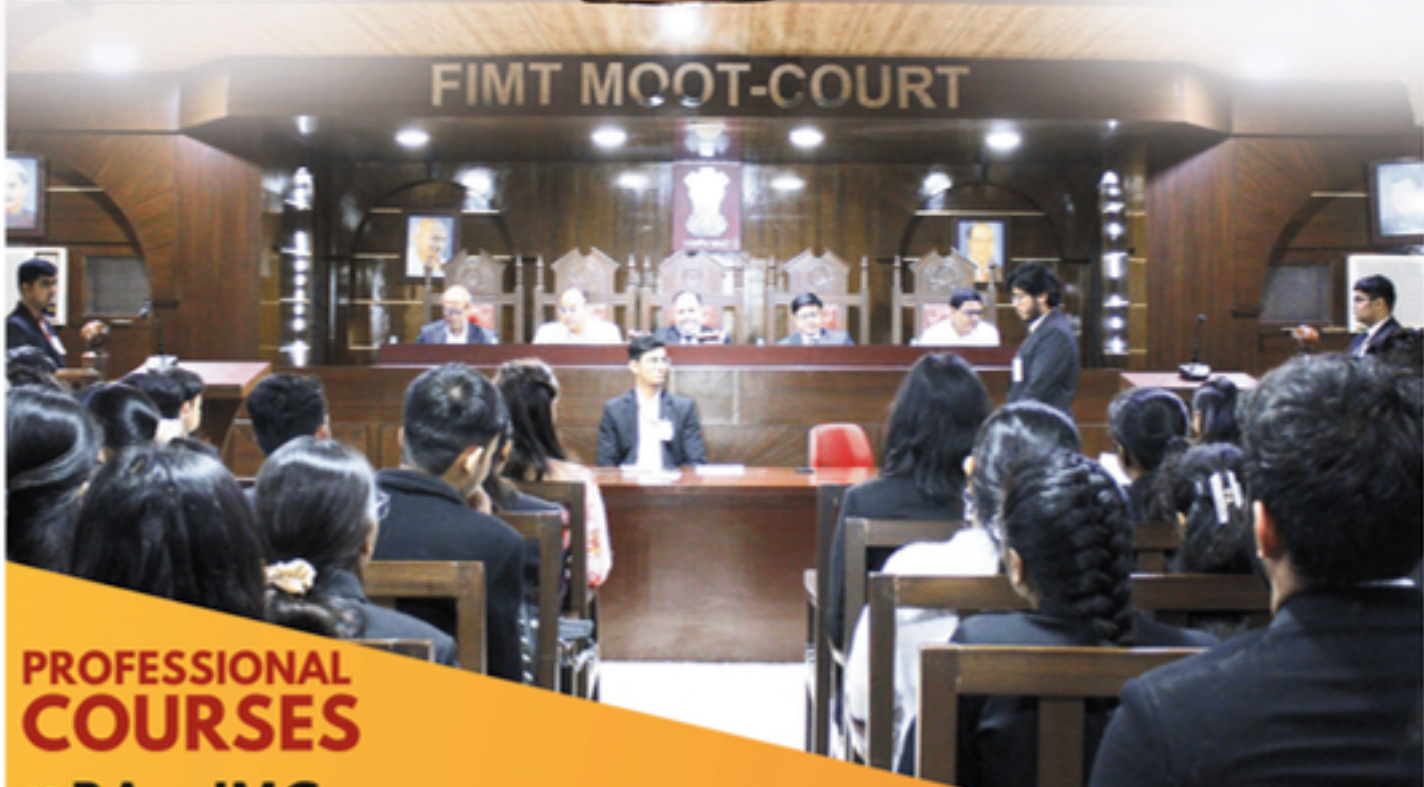
