



General Guideline for Dissertation (BALLB, Xth Semester)

1. Dissertation topic provided by the Director, FIMT-School of Law and Academic Committee Members shall be final and will not be changed.
2. All the research work shall be submitted to the concerned supervisor on or before 26th April 2018. The work shall be duly signed by the concerned supervisor.
3. The research work shall contain the cover page print on the top of the work.
4. The size of the report would depend on the dissertation undertaken which must be of 80-100 pages. All the students are required to use uniform font and format i.e., Times New Roman in size 12, sub-heading 14, 1.5 spacing on A4 size paper and footnotes and reference 10 throughout the text of the dissertation.
5. All students are required to follow the ILI rules of footnoting.
6. 75 marks- Dissertation and 25 marks- External Viva.
