(A). 1st Round of Counseling for verification of documents & allotment of Seats on merit & payment of fee.

All General and Reserved Candidates - 8th August 2024 at 10:00 AM

(B) 2nd round Counseling, if required against vacancies (if any) after completion of 1st Round of Counseling will be notified on the website of the Institute on 08th August 2024 at 5.30 PM.

Important Instruction:

1. Reporting timings of the candidate is from 10:00 AM to 11:00 AM in the Institute. Any extension of the said timings will be maximum 30 minutes i.e. till 11.30 AM.
2. Candidate whose names appeared in the merit list shall come personally along with parent/Guardian with necessary documents for verification and deposit the prescribed fee. Details of the documents to be submitted at the time of admission along with fee detail is available on the website.
3. Candidates having reported in time as mentioned above for the Counseling, shall get all their documents verified first, to ascertain their eligibility. After successful document verification, all the eligible candidate shall be called strictly on merit basis based on percentage of marks obtained in qualifying examination for seat allotment. The process shall continue till the vacancy is available and shall be stopped as and when seats filled up. Kindly note that mere invitation for counseling/participation in counseling does not guarantee admission.
