# PROGRAMMES

## INTEGRATED BBA-LLB (HONS.) : 5 YRS.

BBA-LLB is an Undergraduate Administrative Law professional course which is a Higher Academic Standard Course of five years with duration of 10 Semesters. It is called an Integrated Course because its course curriculum involves the study of Commerce and Business Administration etc. along with the in-depth study of law and legislature. During the program the students Study Principles of Management, Managerial, Economics & Management, Organizational Behaviour, Marketing Management, Strategic Management And Human Resource Management along with Law of Contract, Legal Theory, Environmental Law, Advocacy Skills, Indian Penal Code, Family law, Code of Civil Procedure, Criminal Procedure Code, Business and Commercial Laws, Intellectual Property Rights, Tax Laws, Law of Torts, Banking and Insurance Laws, International Law, International Trade Law etc. Moot Court activities conducted at FIMT ensure that students of law have an in-house experience of handling legal problems given to them in a hypothetical situation to be argued on legal grounds.

## INTEGRATED BA-LLB (HONS.) : 5 YRS.

BA-LLB is five year integrated graduation program, divided into ten semesters. The program has been prepared to create dynamic and dedicated professionals who are well trained in legal domain. During the course, the students study History, Political Science, Economics, Sociology, Law Of Contract, Legal Theory, Environmental Law, Advocacy Skills, Indian Penal Code, Family Law, Code of Civil Procedure, Criminal Procedure Code, Business and Commercial Laws, Intellectual Property Rights, Tax Laws, Law of Torts, Banking and Insurance Laws, International Law, International Trade Law etc.. Moot court activities conducted at FIMT ensure that students of law have an in-house experience of handling legal problems given to them in a hypothetical situation to be argued on legal grounds.

## LLM (CORPORATE LAW) : 1 YR.

LLM is a One year post graduation Degree Program. The School of Law - LL.M. aims to explore and identify novel areas of law and policy through relentless engagement in developing legal theory and practice, academic potential, critical analytical ability and advocacy skills so as to fully equip the students with a learning which is intellectually stimulating, socially vital and professionally enriching. This course is intended to impart intensive knowledge and training in Law subjects and helps students to acquire wider perspectives both for legal responsibilities and professional application. The Program provides candidates with the opportunity to equip themselves for active and effective participation, as professionals, in legal counselling, advocacy and decision-making.

During the one year course students get the insight in the field of law research regular interaction from industry & academic personalities through workshops, Internship, visits & guest Lectures.

## FACULTY & THE INTELLECTUAL ENVIRONMENT

The faculty members of FIMT SCHOOL OF LAW are outstanding scholars and practitioners recruited from

around the world representing diversified legal systems, social backgrounds, and national cultures. ## CURRICULUM & INTERDISCIPLINARY COURSES

FIMT SCHOOL OF LAW has created opportunity for its students to pursue global legal education through a curriculum and pedagogy that best reflects the study of international law, comparative law and foreign law along with domestic law.

## MOOT COURT , MOOTING AND ADVOCACY

A Moot Court is an extracurricular activity in which students take part in a simulated court proceeding, which usually involves drafting briefs (or memorials) and participating in oral argument. Moot court and law review are the two key extracurricular activities in which law schools are encouraged to take part. The students taking part in the moot court competition tend to focus on subjects such as public laws, human rights law, international humanitarian law, trade law, and international commercial arbitration.

The Moot Court Society (**JUSTICE PREVAILS**) is a student led initiative, which works hand in hand with the administration for planning, training and executing its activities.
