### ELIGIBILITY CONDITIONS FOR ENROLLMENT IN NCC :

- Enrollment Applicable For Male - Students Of Semester First (1st) For All Courses.
- Citizen Of India Or A Subject Of Nepal.
- Bearing Good Moral Character
- Enrolled In An Educational Institution.
- Meets The Prescribed Medical Standards.
- Must Fulfil All Required Prescribed Physical Fitness Parameters.
- Age - Senior Division/Wing (Boys/Girls) – Up To 26 Years
- Enrolment Period - Senior Division/Wing (Boys/Girls) – 3 Years
- Height: - Minimum Should Be 157.5 Cms. However,
- There Is A Relaxation Of Height For North Eastern Regions Of India.
- Final Selection Will Be Done By The Ncc Officials

### WHAT TRAINING IS PROVIDED TO NCC CADETS?

- Candidates are trained in drill, shooting, physical fitness, First aid, map reading, sailing and camp training.
- Out of the entire training period, every cadet of the Senior and Junior Division has to undergo service training for a minimum period of 75% of total hours during the annual college and school session, which is compulsory for every cadet except in the case of some medical case.
- Every cadet during the training year to attend an annual training camp of 14 days duration in the case of Senior Division and of 10 days duration in the case of a Junior Division.

The Moot Court Society {MCS} is a dedicated cell, which aims to provide a platform to students to inculcate and enhance advocacy skills. This Society aims to give a chance to all those students who are eager to take participation in National Moot Court. It organizes, through its faculty and students' body, various internal moot court competitions, thereby enabling students to participate in external moot court competitions organized nationally.

The chance to become a member for the moot court society to all those students who are enthusiastic and eager to work as part of the Moot Court Committee of FIMT (SCHOOL OF LAW) NEW DELHI, to take it ahead and strengthen the primary objective of having this committee. The members of the MCC will have a collective responsibility for all the Moot Court work in the college.

The duration of the members shall be for the continuing academic session or till the reconstitution of the next moot court committee.

Mooting can best be described as an activity that comes closest to being a lawyer while still studying at law school. It involves identifying legal issues out of a complex factual scenario, doing exhaustive research on those issues to advance arguments with authorities, followed by drafting extensive written submissions and finally the gruelling orals before a bench of eminent judges. In a nutshell, it is everything a lawyer is expected to do once he starts practising law.

## MOOT COURT SOCIETY JUSTICE PREVAILS



FIMT SOL organizes moot court competition every year . A moot court competition simulates a court hearing (usually an appeal against a final decision), in which participants analyse a problem, research the relevant law, prepare written submissions, and present oral argument. Moot problems are typically set in areas of law that are unsettled or that have been subject to recent developments.

## FACULTY & THE INTELLECTUAL ENVIRONMENT

The faculty members of FIMT SCHOOL OF LAW are outstanding scholars and practitioners recruited from

around the world representing diversified legal systems, social backgrounds, and national cultures. The most important and defining aspect of legal education that is being offered at FIMT SCHOOL OF LAW is its ability to bring together some of the most amazing legal minds and scholars in humanities, social sciences and business studies to teach and engage with the students of law in the BA/BBA LLB (Hons.), LL.M. programmes.

## CURRICULUM & INTERDISCIPLINARY COURSES

FIMT SCHOOL OF LAW has created opportunity for its students to pursue global legal education through a curriculum and pedagogy that best reflects the study of international law, comparative law and foreign law along with domestic law.

FIMT SCHOOL OF LAW students receive instruction in areas such as Advanced Corporate Law, Alternative Dispute Resolution, IPR & Economics, International Investment Law, Labour and Industrial Law and Taxation and Property Law.

In addition, student electives include highly relevant areas such as Competition Law, Futures and Options, Global Financial Markets, Infrastructure Law and Finance, the Law of the WTO and the Law and Economics of Trade Remedy Actions.

The students of FIMT SCHOOL OF LAW have a unique opportunity to be part of a larger university that promotes interdisciplinary study of a range of courses across the schools of business, International affairs, public policy, liberal arts and humanities.

This is done by cross-registration of over 10 courses that students can choose to study from different schools of FIMT. A unique feature of education at FIMT SCHOOL OF LAW is the interconnectedness of the study of law and business or law and social sciences.

## MOOT COURT , MOOTING AND ADVOCACY

A Moot Court is an extracurricular activity in which students take part in a simulated court proceeding, which usually involves drafting briefs (or memorials) and participating in oral argument. Moot court and law review are the two key extracurricular activities in which law schools are encouraged to take part. The students taking part in the moot court competition tend to focus on subjects such as public laws, human rights law, international humanitarian law, trade law, and international commercial arbitration.

FIMT SCHOOL OF LAW has a vibrant and active mooting culture. The Moot Court Society (**JUSTICE PREVAILS**) is a student led initiative, which works hand in hand with the administration for planning, training and executing its activities. FIMT SCHOOL OF LAW hosts the INTER & INTRA COLLEGE /UNIVERSITY Moot Court Competition inviting law schools from in and around India., Moot Court Society hopes to create a strong tradition of successful mooting for years to come.

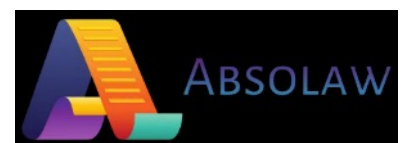

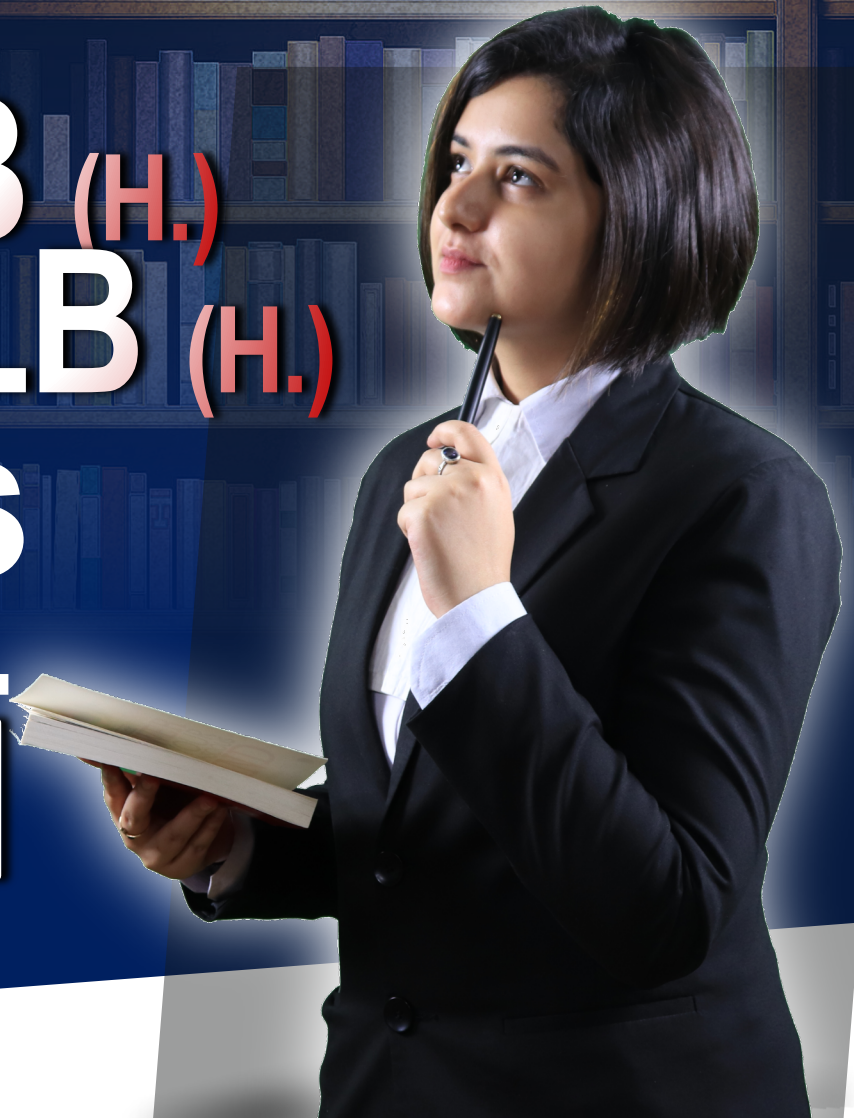

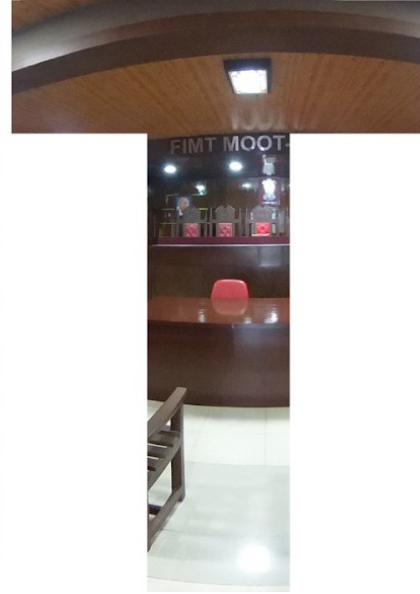
