## CIRCULAR

All the students of the 1<sup>st</sup>, 3<sup>rd</sup>, 5<sup>th</sup>, 7<sup>th</sup> & 9<sup>th</sup> Semesters are hereby informed that the 3<sup>rd</sup> Edition of Nani Palkhivala Quiz on Constitutional Law, 2023 is going to be organised by Lex Consilium Foundation in partnership with Konrad Adenauer Foundation (Konrad-Adenauer-Stiftung). The event will be conducted on 5th February, 2023 at Le Meridien, Connaught Place, New Delhi. The quiz will be designed to test not only the understanding of the Constitution of India as amended and its application but also the knowledge of the constitutional bench decisions of the Supreme Court of five judges or more decided till 31st August 2022.

The competition will be conducted in two rounds; a preliminary round by way of written test (individual performance) and the final round in the shape of an oral quiz (team efforts). The top six teams from the preliminary round will advance to the final round. **Registration and Participation amount of Rs.3000/- per team** is to be paid by online mode in favour of Lex Consilium Foundations. Provisional registration will be completed on receipt of the scanned registration form and payment details. Registration will be completed on receipt of physical copies of the registration form with payment details. Candidates are to report to the allotted test center by 08:30 AM before the schedule commencement of the test for verification. No candidate will be admitted 15 minutes after the commencement of the test.

Each student will carry the Institution identity card signed by the VC, Dean, Principal or Head of the Institution with his/her stamp. The participants are required to be dressed in formals.

Furthermore, only three teams from one institute are allowed to Participate and each team shall consist of 2 students. The **last date for registration is 4th February, 2023**. It is requested that kindly grant permission to the students in order to participate in the above-mentioned event. Furthermore, the guidelines regarding the Research Paper competition are attached herewith. The interested students may approach Mr. Mudit Jain (Assistant Professor, Law) and Mrs. Deepanjali (Assistant Professor, Law) latest by 4th February, 2023
