

Guidelines For The Preparation And Submission of Court Diary (BA LLB/ BBA LLB Xth Semester)

1. Minimum period of internship shall be 12 weeks.
2. Internship may be done with Lawyers, Law firms, Law offices, Honb'le Judges etc.
3. Students have to prepare and submit a court diary for minimum of 100 pages.
4. Court Dairy should present a detailed account or various tasks handled by the students during internship. The report should present in the following sequence.
 - i. A brief account of the organization/place of internship
 - ii. The internship experience - reasons for the choice of the firm. law office etc..
 - iii. Results -what could the student learn from the internship;
 - iv. How many hours per week the students spent with the officer/lawyer/firm etc.
 - v. An overview of the nature of internship/ wise specific tasks assigned to the internee. the work assignment. Duties and responsibilities.
5. The students shall attach with the report photocopy of duly signed certificate of Internship from the concerned. Students shall carry original copy of internship certificate at the time of viva.
6. Students are required to submit the court diary in FIMT office after the viva.

1. Dissertation topic provided by the Director, FIMT -School of Law shall be final and will not be changed.
2. All the research work shall be submitted to the concerned supervisor and work shall be duly signed by the supervisor only.

Formalities of Submission

1. The word limit for the body of the dissertation (excluding the title page, preface, table of contents, declaration of originality (by student), certificate by supervisor/s, acknowledgement, list of abbreviation/acronyms, abbreviations, bibliography, etc.) shall be 25,000 to 30,000 words (approximately 80-100 pages).
2. Dissertation shall be typed in Times New Roman, Font size 12 and printed in 1.5-line space on the single side of the paper with 1 inch margin on all sides.
3. A student shall not be allowed to submit the dissertation without a duly signed forwarding certificate by the faculty supervisor/s.
4. A student will have to submit three copies of the dissertation to the Academic Section and one copy to his/her supervisor/s.
5. A student is required to follow the ILI rules of footnoting.
6. It is compulsory for the students to do a periodic meeting with their supervisor at least twice a month.
7. 75marks- Dissertation and 25marks- External Viva.
8. A Hardbound Copy and soft copy of the dissertation must be submitted according to the date notified by the college.
9. As per the UGC Norms the Plagiarism should not exceeded more than 10%.

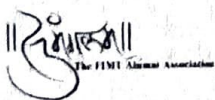
