Dear Students (BA LLB/BBA LLB of 2015-2016 Batch)

We hereby inform you that a Division Bench of Hon'ble High Court in its common Judgment and Order in LPA733/2017 and LPA734/2017 dated 28.01.2019 has held that the Enhanced Fee Structure as determined by the State Fee Regulatory Committee and duly submitted to the Government of NCT Delhi on 24th November 2014 shall be applicable to the students admitted in the Academic Session 2015-16 and the Institutes affiliated to GGSIPU Delhi are within their right to claim the difference of fee structure from the students for a particular course for the Academic Session 2015-16.

Further in a recent judgment and order dated: 27.02.2019 in a Writ Petition number WP(C)7966/2017, the Hon'ble High Court has reiterated that the Institutes concerned are within their right to recover the difference in the fees from the students for the said years in terms of the judgment and orders of the division bench of the Hon'ble High Court of Delhi dated January 28,2019.

In pursuant of the aforesaid Judgment and Orders, the students of (2015-2016 Batch) of 5 years Integrated BA LLB and BBA LLB programmes, who are presently pursuing in the 8th Semester are required to pay the difference of fee structure, as per details given below:
